NOTICE OF MOTION:

Take Notice that Lara Johnson (“hereinafter called the Applicant”) intends to make an application to this court on a date to be determined by the Registrar for orders in the following terms:

An Order confirming Respondents – on behalf of the organization or Head of State they represent – Consent / Edit / Objection Response to:

[A] Authorize EoP PoW TRC to End Abel and Kane Cold War Negotiations:

Ecology of Peace Truth and Reconciliation (“EoP TRC”) to End Abel and Kane Cold War [eoptrc-akcoldwar¹] negotiations to implement [eop-nwo-sco²] EoP Scientific and Cultural law [eop-scicultlaw³] as international law; by process of EoP UN Resolution; to [A] enable responsible freedom [responsible-freedom⁴] orderly and humane – de-industrialization and depopulation [eop-v-wip-deindpopn⁵], prisoner release [prisoner-pardon⁶], land reform [eop-landreform⁷] and denuclearization [eop-denuke-defn⁸] – shut down of the WiP Ponzi Swamp economy [eop-sdwipecon⁹]; [B] require all citizens of all races, religions, nations, to breed [one-child-law¹⁰] and consume below ecological carrying capacity limits [eop-footprint¹¹]; or be humanely eliminated from the planetary genepool [crimes-of-aggression¹²]; [C] nationalize all property and provide all responsible freedom [responsible-freedom¹³] oath citizens: (i) with cultural law self rule [cult-law-self-rule¹⁴] for groups with subjective racial, religious & gender identities; and (ii) a property ration [property-ration¹⁵] land reform [eop-landreform¹⁶] to enable their shelter and survival self-sufficiency to enable the rebuilding of a relocalized low-tech organic agrarian sustainable future.

[B] If EoP TRC: Authorize EoP – Sustainable Security / Climate Change & Ecological Overshoot Emergency - UN Resolution:

Ecology of Peace recommended: [A] UN Security Council and General Assembly Resolution to Implement Ecology of Peace Scientific and Cultural law as international law; [B] Suggested Amendment to Crime of Aggression Definition of Rome Statute of International Criminal Court.

[C] If No EoP TRC: Authorize US v McVeigh Siberia PoW Suicide:

Logistics: (a) Respondent Lapenn on behalf of Respondent NSA: Gen Paul Nakasone and/or Timothy McVeigh's NSA superior; authorizing the release of Timothy McVeigh to travel to South Africa and to Russia with applicant for their joint assisted suicide in Siberia; (b) Respondent Lapenn and Respondent Petrakov on behalf of Respondent NSA Dir Gen Paul Nakasone and Respondent FSB Dir Gen Alexander Bortnikov negotiating the authorized release of Timothy McVeigh to travel to South Africa and to Russia with applicant for their joint assisted suicide in Siberia; (c) Respondent Sisulu authorizing a visa for Timothy McVeigh to travel to Russia via South Africa; (d) Respondent Petrakov issuing a visa for Applicant and Timothy McVeigh to travel to Russia for their assisted suicide departure in unmarked graves in the Siberian wilderness.

TAKE NOTICE FURTHER that the attached Affidavit and EoP UN Resolution documentation enclosures filed herewith will be used in support of this application.

TAKE NOTICE FURTHER that Applicant shall be representing herself and her Ecology of Peace culture/religion, as an effective In Forma Pauperis Pro Se / Propria Persona / Litigant in Person Applicant.

TAKE NOTICE FURTHER that 16 Taaibos Ave, Heatherpark, George, 6539, and/or eop-leg-sub@tygae.org.za, and/or PO Box 5042, George East, 6539, is appointed as the address / email/ landmail address at which the applicant will accept notice and service of all process in these proceedings.

TAKE NOTICE FURTHER that if you intend opposing this application you are required to (a) notify applicant in writing within ten days of service of this application; (b) and within 10 days after you have so given notice of your intention to oppose the application, to file your answering affidavits, if any; and further that you are required to appoint in such notification an address referred to in rule 55(1)(g) at which you will accept notice and service of all documents in these proceedings.

TAKE NOTICE FURTHER if no such notice of intention to oppose be given, by one or more respondents; the application will be made on a date, as agreed upon

between applicants, opposing respondents and the registrar, subsequent to filing of all opposing and reply affidavits.

If EoP UN Resolution is authorized as international law; EoP TRC Negotiations are considered resolved, McVeigh and all other prisoners worldwide are pardoned; in accordance to EoP TRC prison pardon [prisoner-pardon.tygae.org.za] policy; and the case is closed. If EoP UN Resolution is not authorized as Intl law; EoP TRC Negotiations are considered terminated; authorizing – in the absence of any objections – Applicant and McVeigh Siberia Assisted Suicide.

[2] If no Respondents Consent to Authorization of EoP TRC to End Abel and Kane Cold War Negotiations:

[2.1] EoP TRC Negotiations are considered terminated; authorizing – in the absence of any objections – logistics negotiations for Applicant and McVeigh Siberia Assisted Suicide.
